**III. Discussion/Action Items**

- a. **Army Corps of Engineers: Reservoir Operations 2022/2023** – Jenny and Mary from Water Management, Sacramento District, provided a brief update. Jenny shared that they oversee the flood operations. They are updating the water control manual, training dam operators and every year they visit the core projects and walk through the water control plan with the project staff.
- b. **San Joaquin County OES Storm Response 2022/2023** – Tiffany Cacho shared data and information regarding the storms that came through San Joaquin County last year. Some of the challenges included downed power lines, flooding, heavy winds, hundreds of fallen trees and debris. Waterways exceeded normal channel capacity; many were the smaller unmaintained channels. However, there were no injuries or fatalities during the January storm system. The Office of Emergency Services (OES) main goal during the whole process was to support operations, life safety, and the environment.
